IV. ACADEMIC ELIGIBILITY:

Masters' Degree: Applicant possessing Bachelor Degree as specified above is eligible to seek admission to Masters degree with a minimum OGPA of 6.50 out of 10.00 or its equivalent in Bachelor's degree. Such candidates shall also enclose certificate of English language proficiency like ELTS/TOFEL (certificate not required for Indian Students studied in English medium).

Doctoral Degree: Applicant possessing Master's Degree in the concerned subject as specified above (with course work and Research) is eligible to seek admission to Doctoral degree with a minimum OGPA of 7.50 out of 10.00 or its equivalent in Master's Degree. Such candidates shall also enclose certificate of English language proficiency like ELTS/TOFEL (ELTS/TOFEL certificate not required in case of Indian students).

V. DURATION, MEDIUM OF INSTRUCTION, SYSTEM OF EDUCATION OF DEGREE PROGRAMMES:

Doctoral Degree: A minimum period of three academic years (6 Semesters) shall be required for completion of the Ph.D. degree programmes.

Masters Degree including MBA (ABM): A minimum of two academic years (4 Semesters) shall be required for the completion of course work, Research, Thesis/Project report preparation and examination leading to the award of Master's degree.

System of Education & Medium of Instruction: All the Masters & Doctoral degree programmes are taught under semester system in English medium only.

VI. ADMISSION PROCEDURE: The admission committee will prepare the list of eligible candidates based on merit considering the eligibility prescribed for admission and recommend to the University for necessary approval and upon approval, the Registrar will notify the same and communicate to the candidates. The academic regulations pertaining to regular Master's degree programmes are applicable for students admitted under NRI quota.

VII. RESERVATION OF SEATS: The seats shall be reserved in favour of NRI/Children's of NRI/ NRI sponsored candidate well within the existing 10% over and above the intake of the respective Degree programmes not exceeding one students per department (Except MBA (ABM) degree programme). Admission will be made as per the recommendations of the P.G. Admission committee based on the merit of the candidate in the given discipline.

Definition of NRI candidate / NRI sponsored candidate shall be as given by Govt. of India / Karnataka Education Authority.

VIII. FEE TO BE PAID BY THE CANDIDATE AT THE TIME OF JOINING THE DEGREE PROGRAMME:

- 1. NRI sponsored candidates shall pay Institutional Economic fee of US \$ 4000/- for Master's Degree / MBA(ABM) and US \$ 5000/- for Ph.D. degree programmes (for every year) along with Regular semester fee as prescribed by University from time to time.
 - NOTE: 1. The fees Prescribed may change from time to time
 2. One US \$ in equivalent to as per the existing rate on the date of payment.
- 2. He / She shall pay Health Insurance premium as prescribed from time to time. If the candidate is required to stay formore than the prescribed duration to complete the degree, he/she shall pay the Institutional Economic fee and other fee/charges as prescribed for every year
- 3. The candidate will be exempted from payment of Institutional Economic fee if he/she is expected to complete the degree programme within one semester after the prescribed duration to complete the degree, i.e. the first semester of the following prescribed academic years.
- 4. If the Candidates admitted under NRI quota fail to complete the PG degree within the prescribed semesters, 25% of the Institutional Economic fee shall be paid every year, apart from semester fees till the completions of the degree as per academic regulation of PG degree programmes.
- 5. Rs.1,500-00 towards Group Health Insurance / student aid fund to be paid by each Candidate every year.
- 6. The Candidate has to pay the applicable other fees extra, applicable if any.

IX. APPLICATION AND FEE:

Application (PDF) has to be downloaded from the University Website :www.uasbangalore.edu.in from 1-12-2021 to 31-12-2021.

The duly filled in application along with the Xerox copies of educational documents and Notarised affidavit of the Undertaking by the Parent and candidate, including Physical fitness from the Govt. Hospitals, DD for Rs.2000/-(Rupees Two thousand only) towards Application fee drawn in favour of Comptroller, UAS, GKVK, Bengaluru-65, shall be submitted to the Registrar, UAS, GKVK, Bengaluru-65 by post or personally on or before 10-1-2022 during office hours on working days (Monday to Friday from 8.30 am to 4.00 pm and on Saturday from 8.30 am to 12.00 Noon). The Demand Draft should be purchased between 1.12.2021 to 31.12.2021only.

X. Undertaking:

- 1. The Parent and Candidate are required to give an undertaking on stamp Paper (Rs.100/-)notarized from the residing state/ country where the candidate & Parent living depending upon the address of the Candidate & Parents should be enclosed.(Annexure I).
- 2. An Undertaking by the Sponsorer on stamp Paper (Rs.100/-) or equivalent currency in the (sponsorer country) notarized from the foreign country or India where the sponsorer living (depending upon the address of the sponsorer country) should be enclosed(Annexure II)

Notarised under taking after the last date prescribed for submission of filled in applications will not be considered.

- 2. On receipt of selection letter, the Candidates shall confirm his / her willingness to join the programme in writing for which he / she has been provisionally selected for admission. No change of subject / campus is entertained subsequently.
- 3. The University will not own the responsibility of Candidate's involvement in any unlawful activities during the period of his / her study and candidate himself / herself is solely responsible to appear for any enquiry by the police.
- 4. The confirmation of the admission is subject to the verification and correctness of all original transcripts / certificates, of prescribed fees and fulfillment of all other admission requirements by the concerned authority.
- 5. Payment should be made only in US \$ or equal to Indian rupees.
- 6. The College and Course will be allotted based on the meritand /or by option to respective campus including Mandya Campus and the seats available in the particular college as per the seat matrix issued by the University.
