Such of those Teachers/Scientists of the UAS (Bengaluru) who wish to apply for deputation to Ph.D programme inside/outside the University, in the areas of specialization (as Specified in the Notification:No.AO/Gen/Depth-Ph.D/Subjects/2023-24 Dated 12-04-2023) for the academic year 2023-24, may submit their application in the prescribed proforma (enclosed) through proper channel to the Administrative Officer, UAS, GKVK, Bengaluru, **on or before 06-05-2023 i.e., last date for submission of application for admission within the University. For outside the University, the last date announced by the University concerned may be followed.** Separate applications should be submitted for each subject in the prescribed proforma and if applied for more than one subject enclosures may be sent along with any one application only.

Applications received after the last date will not be considered and no advance copy will be entertained.

Further, the candidates may seek admission in any of the following and avail deputation facility outside University of Agricultural Sciences, Bangalore within one year from the date of notification of selection, failing which the deputation shall stand cancelled and no extension of time will be granted.

4. Technical Universities/Reputed R & D Institutions-as applicable to concerned Department

The consideration of deputation facility is **for two(2) semesters duration of course work within the University, three(3) semesters duration for course work outside the University within the state and 3 years duration for outside the state**, with course work as mandatory for aspirants and subject to fulfillment of all other terms and conditions stipulated in the deputation guidelines already notified vide this office Notification No.AO/Gen-II/Deputation/2004-05 dated 03/09/2004.
