Applications are invited from the eligible candidates for admission to the vacant seats of Under Graduate degree programmes in the University of Agricultural Sciences, Bangalore under NRIs/Children of NRIs/ candidates sponsored by NRI quota for the academic year 2024-25

I. Academic Eligibility:

Applicants who have passed two (02) years Pre-University course (10 + 2) or equivalent examination with:

- 1. Minimum of 50 per cent of total marks in Physics, Chemistry, Mathematics & Biology subjects are eligible for all Under Graduate Courses.
- 2. Those who have studied only Physics, Chemistry & Biology (with a minimum of 50 per cent of total marks in Physics, Chemistry & Biology subjects) are also eligible for B. Sc. (Hons.) Agriculture, B.Sc. (Hons.) Sericulture and B.Sc. (Hons.) Agri-Business Management, B.Sc. (Hons.) Food, Nutrition and Dietetics, B. Tech. (Biotechnology) and B. Tech. (Food Technology).
- 3. Those who have studied only Physics, Chemistry & Mathematics (with a minimum of 50 per cent of total marks in Physics, Chemistry & Mathematics subjects) are eligible only for B. Tech. (Agricultural Engineering).

II. Number of Seats & Eligibility:

- 1. Totally 10% of the seats over and above the intake (strength) in a given degree programme shall be provided to NRIs / Children of NRIs / candidates sponsored by NRI.
- 2. Definition of NRI candidate / NRI sponsored candidate shall be as given by Government of India / Karnataka Examination Authority.
- 3. Candidate should have studied in English medium at higher secondary or 10 + 2 level or English proficiency could be evidenced by producing certificates like ELTS or TOEFL at the time of admission (This condition is not applicable to students who have studied in English medium).

III. Application and fee:

- a) An Institutional Economic fee of US \$ 8,000 (for CoA, GKVK)/ US \$ 6,000 (for other Constituent colleges) or equivalent Indian Rupees per annum to be paid at the time of admission and US \$ 4,000 (for CoA, GKVK)/ US \$ 3,000 (for other Constituent colleges) per semester during II and subsequent years by the admitted Candidate/Parent/Sponsorer in the form of DD drawn in favour of Comptroller, UAS, GKVK, Bangalore, Payable at Bangalore.
- b) Fee has to be paid every year before the commencement of the academic year, along with other semester fees as indicated above. Group health insurance has to be paid by cash at the concerned college at the time of admission,
- c) If the candidates admitted under NRI quota fail to complete the UG degree in Four years or Eight Semesters, then onwards 25% of the Institutional Economic fee shall be paid every year, apart from semester fees till the completion of the degree as per academic regulations of Under Graduate Degree Programmes.

VIII. CONDITIONS-:

- 1. The admission is governed by Govt. orders / UAS(B) regulations issued from time to time and approval of the NRI admission committee.
- 2. Late submitted/incomplete applications/applications without payment of prescribed fees will not be considered.
- 3. Number of seats notified under this notification is subject to alteration within the number of seats provided and notified as per the central and State Government orders. The University reserves the right to fill-in / not to fill-in any or all the seats notified.

- 4. Furnishing any false information in the application by the candidates is liable for cancellation of admission at any point of time.
- 5. The seats shall be allotted subject to the fulfilment of all the eligibility conditions prescribed by the University.
- 6. The prescribed fee paid by the candidate or the concerned, on behalf of the candidate, will not be refunded by the University under any circumstances.
- 7. First preference shall be given for candidates with PCMB subjects during seat allotment, followed by PCB/PCM in 10+2/equivalent exams as prescribed. However, such admitted students have to undergo compulsory remedial Mathematics/Biology courses to fulfill the academic requirement for completion of the UG degree programme.
- 8. The students admitted under NRI quota are not eligible to participate in the in any other admission process conducted by any of the Farm Universities of Karnataka.
- 9. If any of the seats (other than B.Sc. (Hons.) Agri.) are vacant, such unfilled seats can be converted to B.Sc. (Hons.) Agri. seats which is left to the description of the UAS, Bangalore.
- 10. If the Candidates admitted under NRI quota fail to remit the prescribed fees within the stipulated date/dates, their admission will be cancelled.
- 11. Candidates admitted under NRI quota will not be transferred from one teaching campus to another teaching campus of UAS, Bangalore under any circumstances.
- 12. No individual intimation will be sent to candidates in this regard.

IX. GENERAL INSTRUCTIONS:

- 1. After the last date of submission of filled-in application, the list of eligible candidates, merit list, selection list and also last date for admission will be uploaded in the University Website www.uasbangalore.edu.in
- 2. On receipt of selection letter, the Candidates shall confirm his/her willingness to join the programme in writing for which he/she has been provisionally selected for admission. No change of subject/campus is entertained subsequently. However, if the selected candidate do not join within the time limit, then the waitlisted candidate on merit will be considered.
