Sub: Award of University Resident Merit Scholarship (URMS) to I year Ph.D. degree programme students under semester system of the University of Agricultural Sciences, Bangalore for the Academic year 2024-25 – reg.

Ref: Approval of the Director of Education & Vice-Chancellor, UAS, Bangalore dated 28.01.2025

Applications are invited for the award of University Resident Merit Scholarship (URMS) for the regular students pursuing I year Ph.D. degree programme students under semester system of the University of Agricultural Sciences, Bangalore for the Academic year 2024-25.

1. The value of Merit Scholarship shall be as specified by the University from time to time.

Degree programme	Rate / p.m.
Ph.D.	Rs. 4000/-P.M.

2. The number of URMS to be awarded shall be one to each subject under I year Ph.D. Degree Programmes during an academic year. This shall restrict to only those students who have possessed Graduate and Post Graduate degree from any recognized State / Central / Deemed Agricultural / Horticultural / Forestry Universities & Other Farm Universities (As per Information Brochure Common PG admissions 2024-25) and seven years of Karnataka state domicile. The deputed, in-service sponsored students are not eligible.
3. In subjects, where the number of eligible students exceeds ten, an additional URMS may be awarded. Further, if the eligible number of students exceeds 20, another URMS may be awarded and thereof.
4. A student shall be eligible to hold any one scholarship/fellowship at a time.
5. A student shall apply for URMS to the Registrar through concerned Dean in the prescribed form on or before notified date.
6. The URMS for the first year Post Graduate students shall be decided on the basis of OGPA of previous degree programme. For subsequent years, URMS will be awarded based on previous year CGPA. If a student declines URMS, the same may be awarded to the next applicant in the order of merit.
7. The URMS shall be terminated at any time if the conduct, progress and attendance are unsatisfactory.
8. A student for the award of the scholarship may submit his/her application as per the Proforma (enclosed) through their Head of the Department to the Dean (PGS), UAS, Bangalore / the Dean (Agri.), College of Agriculture, V.C. Farm, Mandya on or before 13.02.2025.

9. The scrutinized application/s from the Deans / Scientific Officer concerned colleges should reach to this office on or before **18.02.2025**.
10. The students should submit their grievances, if any, within 15 days from the date of notification of the merit list.
